

IDD Services Division INTAKE INFORMATION

Thank you for your interest in receiving IDD services at The Harris Center for Mental Health and IDD. All persons requesting services must complete an Eligibility Intake online packet and an in-person appointment which consist of a financial eligibility assessment, diagnostic eligibility assessment and a service coordination assessment.

BEFORE your appointment will be scheduled, you will need to complete the following two steps:

- 1. Complete an online intake query, by clicking the link below or scanning the QR code. You may also call 713-970-7799. You may also email your name and contact information to iddeligibilitymanagement@theharriscenter.org.
- 2. After you complete your query, you will be contacted by our intake team within 48 hours to review your information and review the intake process at the Harris Center. Prior to the intake process, you will need to gather and submit the following documents.

Diagnostic Assessment Reports from School*

If the individual has received Special Education services, you must provide copies of their Full Individual Evaluations (FIE's) or Comprehensive Individual Assessments (CIA's) ahead of time for review.

Diagnostic Assessment Reports from Other Agencies*

If the individual was seen by other agencies or professionals for suspected developmental delays, intellectual disability or pervasive developmental disorders, copies of these evaluations should also be provided. Examples include evaluations by:

- Other Community Centers, State Supported Living Centers or State Hospitals
- Schools for the Deaf or Blind
- Private hospitals or clinics
- Private psychologists or psychiatrists
- Other educational or training programs/agencies for persons with intellectual disability & related disabilities

Financial Assessment Documents

- Proof of residency for Harris County (current utility bill or lease)
- Proof of your income (SSI award letter, 1 month worth of recent paycheck stubs (if
- minor we will need both parents income), Tax return (if self-employed, get paid in cash)) – Proof of any insurance coverage
- Identification Card, or Driver's License
- Birth Certificate
- Social Security Card (if minor we will also need parents)
- Current guardianship letter (if applicable)

*If you need help in obtaining 'Diagnostic Assessment' documents you may sign a consent form giving The Harris Center staff permission to contact schools, hospitals, doctors, etc. on your behalf, and The Harris Center will help you to obtain the required documents. (A copy of the consent form is attached to this email). This is applicable to 'Diagnostic Assessment' documents only and not documents required for the 'Financial Assessment'.
